



RELEASE OF DRIVING/MOTOR VEHICLE RECORDS

TO: All State Motor Vehicle Departments, other State Agencies, Commercial Driving Record Data Bases or 3rd party Driving Record Checking Services, which store and/or maintain driver/motor vehicle records within the United States.

The Undersigned hereby authorizes the release of his/her complete driving record including, but not limited to, copies of all reports relating to accidents and /or violations to CH2MHill Corporation and it's affiliated and subsidiary companies, including CH2MHill Polar Services, and the University of Alaska Fairbanks (UAF). The Undersigned authorizes the above organizations to accept a photo/fax copy of this Release of Driving/Motor Vehicle Record as an original.

The Undersigned understands that to be eligible to operate a Toolik Field Station (TFS) Science Support Truck or TFS based UAF truck: he/she must have a valid drivers license, be at-least 25-years old or an employee of the Toolik Field Station, must not have an excessive number of driving violations as defined in Table 1, must complete a TFS vehicle operation/safety briefing, must complete the UAF drivers safety class if operating a UAF owned vehicle (State of Alaska official use license plates) and has read the regulations and policy pertaining to the driving privileges, responsibilities, and authorized uses of the TFS Science Support Trucks.

Your cooperation and assistance are appreciated in completing this requirement.

a. Driver has a valid driver's license for the period during which the vehicle will be driven.

b. The driver's driving record must not contain an excessive number of violations.

An excessive number of violations is defined as:

- i. 1 or more Type A Violations in a 60-month period.
- ii. 2 or more Type B Violations in a 36-month period.
- iii. 3 or more Type C Violations in a 36-month period.
- iv. 1 Type B and 2 Type C Violations in a 36-month period.

Definitions of Types of Violations:

Type A – Includes, but is not limited to, DWI, DUI, OUI, refusing a substance test, charges of reckless driving, manslaughter, hit & run, eluding police, any felony, drag racing, having or driving with a suspended license.

Type B – Includes all vehicle accidents regardless of fault.

Type C – Includes all moving violations not in Types A or B such as:

Speeding, improper lane change, failure to yield, running stop lights or signs.

Type D – Includes non-moving violations such as: illegal parking, equipment violations, obstructing traffic, failure to display registration or driver's license.

Complete form and turn in to either TFS Station Manager or, Fairbanks IAB Logistics Staff at least 7 days before you wish to drive the truck.
